Sesto San Giovanni, April 9th, 2018-In compliance with the authorization approved by the Shareholder meeting held on April 28th, 2017, mainly to be used to service the stock option plans, Davide Campari-Milano S.p.A. (LEI code 213800ED5AN2J56N6Z02) announces that between April 3rd, 2018 and April 6th, 2018 it bought back, on the regulated market (MTA) managed by Borsa Italiana, 72,000 own shares at an average price of € 6.1914 per share for a total amount of € 445,779.00

The transactions have been executed by Equita SIM SpA (LEI code 815600E3E9BFBC8FAA85).
